Terms & Conditions

Confirmed Bookings

To confirm your booking O'Malley's Irish Bar requires a deposit of \$100 to secure your date. Full payment of platter selections will be required at the time of ordering. Deadline for platter ordering is 7 days from the celebration date. The \$100 deposit will be taken off the total catering cost.

Minimum Cost's

Minimum costs only occur in relation to the entire venue having to be closed to general public. 18th Birthday Parties we are unable to cater to.

Licensing & House Policy

To comply with Queensland law, all guest under the age of 18 years must be accompanied by their own parents or legal guardian who are to remain at the venue for the duration of their time at the venue. All persons attending the venue must be able to provide adequate identification or proof of age on request. Current passport, proof of age or driver's licence are the only acceptable forms of identification.

The venue reserves the right to refuse entry and or eject patrons for unduly intoxication/disorderly/failure to provide acceptable ID. This is applicable under RSA and Licensing Laws.

If the venue deems a requirement for security to comply with it's liquor licence this will be at a cost to the venue. In the event additional security is required for your celebration, this will be discussed and may incur a fee at the hosts expense.

Any minors under the age of 18 attending a celebration will be required to leave by 10pm. BYO drinks and catering is not accepted.

Final Numbers & Payment

To be able to make your celebration a successful one we ask that final numbers be advised 7 days from the event date. This will ensure catering is sufficient and the amount charged for catering is completed. We understand that there maybe some variations with numbers and we will do our best to assist.

Catering payment will be make prior to the celebration date. If on the date of your celebration you host a bar tab, this will be finalised at the time your celebration draws to a close. We accept cash, all major credit cards including Diners & Amex. O'Malley's can not accept payments via electronic funds transfer or cheques.

Cancellation

A cancellation fee may apply to your celebration if sufficient timely communication is not received. A minimum 14 days from your celebration date is required by the venue. The fee amount is up to the venue and will be determined by the out of pocket expenses incurred.

Damage / Personal Property

Personal gifts and belongings of the host or guests is not the responsibility of the venue. The celebration host accepts responsibility for any costs incurred from damage or breakage of building fixtures or fittings, equipment on behalf of guests. Compensation for items broken or damaged will be assessed by the venue manager and passed onto the host for payment. If additional cleaning is required after the celebration date, this may be passed onto the host for compensation.

O'Malley's Irish Bar does not allow the following items to be used for celebration decorating or styling:

- · Nails, staples/staple guns, screws
- · Blue tac or sticky tape (or any other sticky materials)
- · Confetti or table scatters
